

After welcome address, the agenda of the meeting was kept in front of members.

Agenda: - Discussion & approval

Point 1. To incorporate wealth oriented and health oriented courses in the syllabus.

Point 2. To discuss and finalize course contents of Psychology for under graduate program as an **interdisciplinary course** for the second year in BA with Yoga Science Program.

Point 3 To discuss and finalize course contents of **Pre Ph.D Course work of Psychology** (Academic Session 2023) as per NEP.

The members had a brainstorming discussion and interaction among themselves. The above mentioned points were discussed at length by the members and fruitful suggestions were noted and accordingly syllabuses will be modified.

Program Name: BA with Yoga Science

1. A major modification was suggested by Professor Rakesh Jain (Subject Expert) in Unit 4 and Unit 5 of Stress Management (Interdisciplinary Course, BSYSID – 303A IIIrd Semester. The contents of Unit 4 should be based on Indian Techniques. Unit 5 should be based on practical exposure instead of theoretical aspects.
2. A minor modification was suggested by the members to the paper title of the IVth semester course. Paper title should be **Strength and Virtues** instead of Positive Psychology.






Program Name: Pre Ph.D Course Work

1. A major modification was suggested by the subject Expert in the Elective Paper (Major Trends and major thrust areas of Psychology, Paper Code: Ph.D.CWE01). It was instructed and advised by the subject expert that one unit of **Indian psychology** should be incorporated into the syllabus.
2. A minor modification was also suggested by the subject expert to add **current trends of research** in each unit of the syllabus.
3. A major modification was also suggested by the subject expert in the Second Elective Paper (Psychological Assessment, Paper Code Ph.DCWE-02). It was suggested to incorporate concept of **test construction** as a unit.
