#### **Statutory Bodies:**

**1. Board of Governors (BOG):** The Board of Governors is the University's principal governing body, with the authority to formulate, review, and approve policies, plans, and procedures as well as recommend initiatives for the university's progress and growth on a regular basis.

**2. Board of Management (BOM):** The key role of the Board of Management is to control and administer the university's income, assets, and administrative affairs.

**3.** Academic Council (AC): The Academic Council is the university's main Academic body, and it is in charge of organising, supervising, directing, and monitoring academic quality in teaching, curriculum, and exams.

**4. Finance Committee (FC):** It is the University's main Financial body, responsible for monitoring, organising, and coordinating the university's financial matters.

#### **Non-Statutory Bodies:**

The Vice-Chancellor constitutes various non-statutory committees involving Deans/Directors and Professors/Associate Professors/Assistant Professors/Administrators and Students to decentralize administration. These committees assist in the smooth working of the University's scholastic and managerial exercises. This process of governance ensures participation of faculty and students in day-to-day administration both at academics and other related activities. It ensures transparency in the system as well.

This MOU will be operative under the following Terms and Conditions:

#### Terms & Conditions:

- 1. The duration of the Mutual Internship will be for 6 months per year in total.
- 2. The mutual Internship program will be governed by the terms and conditions mentioned in this MOU and any violation by either of the partner should be brought to the notice of the concerned partner.
- 3. Both the institutions shall appoint coordinator for the smooth conduct of the Mutual Internship Program and for avoiding communication gap if any.
- 4. Both the institution shall constantly monitor the Mutual Internship Program.
- 5. A joint certificate will be issued at the end on the successful completion of the internship.
- Following will be the distribution of jobs and responsibilities of the two partner institutions.
  - a. Kaivalyadhama will depute internees for total 06 months for internship program to the Patanjali Yoga Vidyapeeth, Haridwar (PYV). Kaivalyadhama will pay Rs.3000/- per month for per student to the training institute (PYV).
  - b. An internship diary will be given to the internees by parent institution for recording daily activities carried out by them.
  - c. Training institution shall instruct the internees about expected conduct and behavior during the internship program.
  - d. Training institution shall constantly monitor the internship program and shall inform the parent institution of the internee, if there is any violation of terms and conditions.
  - e. The training Institution shall be responsible for providing hands on training to the deputed students of the college.
  - f. Training institute shall provide at least 30 (IPD/OPD) patients to each PGDY1 internee during the Internship.
  - g. The training institute shall allot duties to the internees.

- h. The training institution shall decide the timetable for the whole day and intimate the same to the deputed internees and to the parent institution.
- i. The training Institution shall maintain the record of attendance of Internees. In case, the Internees are not regular in attendance, it should be immediately brought of the notice of the parent institution of the Internee.
- j. The training institute shall provide boarding, lodging and food facilities free of cost to the Internee.
- k. The training Institution shall issue a certificate in proper format at the end of the internship program, which will be given to the internee.



#### **BY & BETWEEN**

University of Patanjali (UOP), The FIRST PARTY represented herein by its Registrar (herein referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors- in office, administrators and assigns).

#### AND

Bharat Swabhiman Trust (BST) (herein referred as 'Second Party', *represented herein by its Chief Central Coordinators* the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors- in office, administrators and assigns).

**HERE-IN-AFTER**, individually referred to as the "Party" and collectively referred to as the "Parties"

#### WHEREAS:

- **A.** First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- **B.** First Party is a Higher Educational Institution named: University of Patanjali. The party's intent to cooperate and focus their efforts on cooperation within area of skill based Training, Research, Extension of Activities, Job Aspects and Social Welfare.
- C. Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- **D.** Bharat Swabhiman Trust (BST), the second Party works in Yoga Training, *Promotion*, Education and Research & Development activities.
- **E.** BST and UOP agree to explore possibility of engaging in following modes of collaboration:
  - i. To establish a close linkage and functional coordination between BST and UOP for mutual cooperation towards advancement of knowledge of faculties, research scholars and students of both institutions.
- **ii.** Exchange of information on research, teaching, training, learning materials and other literature relevant to their education and research programmes with promotional and propagation of various mutual activities.
- iii. Joint organization of seminars, conference, workshop and short term continuing education programs *(CEP)* on topics of mutual interest with extending invitation to each other's faculty to participate therein.
- iv. Joint proposal and engagement in research or training programs sponsored by funding agencies, while extending invitation to each other's faculty to participate therein.
- v. Exchange of student's on a reciprocal *Basis* for purposes of *promotion*, *training*/education/research.

- F. Terms of any financial arrangement will subject to separate agreement made on Project basis; such as further agreements will include name of those persons responsible for managing implementation etc of collaborative activity.
- G. No party to this memorandum shall use name, logo or any other designation of any of other parties without prior written consent.
- H. Co-ordination: Following arrangements is suggested for co-ordination of collaboration: Each of institute shall appoint one member of the teaching/research faculty to coordinate programme on its behalf.
- I. Tenure and Termination: This MoU will take effect from date it is signed by representatives of two institutions. It will remain valid for a period of five years. This MoU can be reviewed thereafter. Terms of this MoU may be amended by mutual written agreement. Any extension to this MoU will be formally agreed in writing by both parties. Either Party may terminate MoU by giving written notices to other institution six months in advance. Once terminated, neither BST nor UOP will be responsible for any losses, financial or otherwise, which other institutions may suffer. However, BST and UOP will ensure that all activities in progress are allowed to complete successfully.

Arbitration Clause: In case of any dispute relating to any aspect of training academic and research collaboration, Registrar UOP and Chief Central Coordinator of BST will jointly resolve dispute in a spirit of independence, mutual respect and shared responsibility.





#### 1. BACKGROUND

PRF recognized it's strength in areas of research in Yoga & Ayurveda, in same way UOP recognizes it's strength for their unique ideas of education and research in traditional indian culture & civilization including ancient medicine and their mutual interest with PRF in engaging themselves in research and academic collaboration.

#### 2. COMMENCEMENT

This Memorandum of Understanding (MoU) shall take effect on the date of signing and shall continue for a period of 05 years unless terminated earlier in accordance with the provisions of Clause 07.

That the duration of this MoU can be extended on mutual consent of both the Parties.

#### 3. SCOPE AND AREA OF MOU

Goal of this MOU is to foster collaboration, provide opportunity for research experience in yoga, ayurveda, scientific spiritualism and health sciences and to facilitate advancement of knowledge on basis of reciprocity, best effort, mutual benefit and frequent interaction.

UOP and PRF agree to explore possibility of engaging in the following areas/ modes of collaboration:

- Research collaborations (advancement of knowledge of faculty, scientists, research scholars and students of both institutions)
- Exchange of information on research, teaching, learning materials and other literature relevant to their education and research programmes.
- Joint Publications
- Joint organization of seminars, conferences, workshop and short-term continuing education programs on topics of mutual interest with extending invitations to each other's faculty to participate therein.
- Joint proposal and engagement in research or training programs sponsored by funding agencies, while extending invitations to each other's faculty to participate therein. Joint Projects submission in AYUSH and other central and state govt. projects/ Skill development projects.
- Joint Ph.D guide

PRF and UOP agree that following technical description will guide each proposed activity indentified and agreed upon by two institutions:

#### **Research Collaboration:**

UOP and PRF will encourage collaboration in extramural research projects, Ph.D research projects, postdoctoral research project etc. UOP and PRF provide facilities to faculty members of PRF and UOP to explore and prepare joint proposals for fundings.Technical activities and grant sharing between PRF and UOP shall be mutually agreed while submitting such proposal to funding agencies.

Outcomes of joint research in terms of research papers, patents, products etc. will be jointly shared by individuals of both institution.

Research methodology workshops programs for students and faculty of UOP may be conducted by PRF and vise versa. Duration, frequency, adequacy and other modalities of such workshop can be decided on mutual consent.

#### Academic Activities:

PRF and UOP agree to seek means of identifying and inviting scientists & faculty members from each other's institutions to participate in conferences workshop and short courses. Terms and condition for such participation would be worked out by mutual agreement between invited faculty member(s) and institution extending such an invitation. Both institutions would encourage members of their faculty to undertake short visits or take up fixed- term assignments as visiting faculty for Guest Lectures, Workshops and Training.

Terms and conditions for each visit or an assignment, including those concerning stipend and travel, would be worked out between partner both institutions.

PRF and UOP will examine ways of exchanging information of research and education programs and teaching/ learning material and other literature relevant to their education and research programmes.

Both institutions agree to explore ways to share teaching/ learning material and other relevant literature, subject to each institutions policy on intellectual property and publication.

#### 4. JOINT CONTRIBUTIONS

Potential areas for collaborative research will include:

 Access to its research laboratories and assist in development of projects involving the parties.

- Joint submission of research proposals of national and international organisations to obtain support for their common research objectives.
- UOP and PRF shall work specifically in the areas defined in Para 3.

The parties acknowledge that all specific financial arrangements proposed must be negotiated and will depend upon the availability of funds and organisational approvals.

#### 5. CONFIDENTIALITY AND PRIVACY

UOP and PRF recognize that will come into possession of information which the other considers to be confidential, including personal information (Personal Information means information and opinions recorded in any form about in individual whose identity is apparent, or can reasonably be ascertained, from the information or opinion). Each of PRF and UOP convents and agrees that it shall not, at any time, disclose to any third party, any confidential information or another party without first having obtained the prior written consent of the other party.

The provisions of this Clause 5 are intended to and shall be binding upon the parties upon signing of this MoU, and shall survive till the termination or expiry of this MoU.

#### 6. INTELLECTUAL PROPERTY

"Intellectual Property" means and includes all copyright, all rights in relation to inventions (including patent rights), plant varieties, register and inregistered trade marks, registered and unregistered designs and all other rights resulting form intellectual activity in the scientific, industrial, literary or artistic fields.

Each party shall retain all right to existing intellectual property belonging to it and contributed by it ("Background IP") at the commencement of each Research Project arising under this agreement.

If any IPR issue emerges as a result of joint research, then a specific IPr addendum will be jointly agreed upon.

#### 7. TERMINATION

Either of UOP or PRF may terminated this MoU by written notice to the other party. A minimum period of six months notice will be required from a party wishing to terminate the MoU, or such shorter period as the parties may agree upon in writing.

The termination of this MoU shall not affect the implementation of activities that have been undertaken prior to such termination, unless agreements pertaining to such activities explicitly provide for such termination.

#### 8. AMENDMENTS AND SUPPLEMENTARY AGREEMENTS

The parties may agree to amend this MoU at any time by further memoranda in writing Patani (Drug Discovery executed by the duly authorised officer(s) of each party.

## MEMORANDOM OF UNDERSTANDING

BETWEEN WONKWANG DIGITAL UNIVERSITY (WDU) AND UNIVERSITY OF PATANJALI (UOP)

MEMORANDOM OF UNDERSTANDING is hereby entered into by and between and the Wonkwang Digital University, (hereinafter referred to as WDU) and University of Pantanjali (hereinafter referred to as UOP), in order to establish a framework of mutual cooperation, to strengthen ties and achieve development of both parties, through the continuity of educational exchangeprograms.

#### Article1. Purpose

#### **Article2.** Cooperation Areas

- 4) Facilitate the conduct of events and functions in areas of mutual interest by offering suitable venues and other forms of assistance as feasible, and actively assist in development of substantive contents including academic, in the identified areas of mutual interest.
- 5) For reciprocal cooperation and friendship, on other matters of interest not mentioned in the above.

#### Article3. Obligation

This MOU is to clarify faithful obligation on the basis of self-management, mutual trust and cooperation.

#### Article4.Effectivation and the Term of Validity

This MOU is to protect the authority and freedom of both parties, and is effective upon the day and date last signed and executed by the duly authorized representatives of the parties to this MOU. It shall remain in full force and effective for a period of three years from the date of signing, and automatically renewed on completion, for a similar period, unless either of the parties wish otherwise. The MOU may be terminated without cause, by either party, upon a written notice about modification or abandonment.

#### Article5. Application of MOU

1) In case of the matter which cannot be clearly applied according to the MOU, to promote the programs of exchange effectively, the matter will be dealt with, by the agreement of the Head of the Department in charge of the matters of both parties.

2) In case of the matter which cannot be clearly mentioned in the MOU, when disagreement of views on such matter happens, both parties will resolve the issue by mutual agreement through discussion.

#### Article6. Responsibility for protection of the secret information

The official information of the other party which is gotten while undertaking MOU activity will not be disclosed or used for another purpose, or to a third party, without the prior consent of the concerned party.

#### Article7. Other matters

#### All India Institute of Medical Sciences (AIIMS), Rishikesh situated at Virbhadra Road, Rishikesh, Uttarakhand -249203 herein after called AIIMS Rishikesh.

Sharing a common desire to extend and strengthen functional relationship between UOP and AIIMS Rishikesh, we undersigned, mutually agree to share existing facilities and available expertise at our respective institutions, viz. UOP and AIIMS Rishikesh by signing a Memorandum of Understanding (MoU) on 19 of December 2017 and wish to initiate collaboration in different disciplines.

AIIMS Rishikesh recognizes it's strength in areas of patient care, medical education and clinical research, in same way UOP recognizes it's strength for their unique ideas of education and research in traditional indian medicine and their mutual interest with AIIMS Rishikesh in engaging themselves in research and academic collaboration.

Therefore, AIIMS Rishikesh and UOP agree to establish a program for academic and research collaboration in areas of mutual interest and in accordance with terms and conditions set forth in this memorandum of understanding (MoU).

Goal of this memorandum of understanding is to foster collaboration, provide opportunity for research experience in scientific spiritualism and health sciences and to facilitate advancement of knowledge on basis of reciprocity, best effort, mutual benefit and frequent interaction, AIIMS Rishikesh and UOP agree to explore possibility of engaging in following modes of collaboration:

- a) To establish a close linkage and functional coordination between AIIMS Rishikesh and UOP for mutual cooperation towards advancement of knowledge of faculty, research scholars and students of both institutions.
- b) Exchange of information on research, teaching, learning materials and other literature relevant to their education and research programmes.
- c) Joint organization of seminars, conferences, workshop and shortterm continuing education programs on topics of mutual interest with extending invitations to each other's faculty to participate therein.

- d) Joint proposal and engagement in research or training programs sponsored by funding agencies, while extending invitations to each other's faculty to participate therein.
- e) Exchange on a reciprocal basis of students at undergraduate, graduate and doctoral levels for limited period of time for purposes of education and / or research.

AIIMS Rishikesh and UOP agree that following technical description will guide each proposed activity identified and agreed upon by two institution.

Terms of any financial arrangements will be subject to separate agreements made on a case by case basis; such as further agreements will include name of those persons responsible for managing implementation etc of collaborative activity.

#### A. Research Collaboration:

UOP and AIIMS Rishikesh will encourage collaboration in extramural research projects, PhD research projects, postdoctoral research project etc with emphasis on Randomized Controlled Trials (RCT) and metanalysis. UOP and AIIMS Rishikesh provide facilities to faculty members of AIIMS Rishikesh and UOP to explore and prepare joint proposals on metanalysis and RCTs on thrust areas for funding. Technical activities and grant sharing between AIIM -Rishikesh and UOP shall be mutually agreed while submitting such proposal to funding agencies.

- I. Outcome of joint research in terms of research papers, patents, products, etc will be jointly shared by individuals of both organizations.
- II. Research methodology workshops programme for students and faculty of UOP may be conducted by AIIMS Rishikesh and vice versa. Duration, frequency, adequacy and other modalities of such workshops can be decided on mutual consent.
- III. UOP faculty can be guide- co- guide for PhD and PG-Programmes of AIIMS Rishikesh and vice-versa.

#### B. Academic activities:

AIIMS Rishikesh and UOP agree to seek means of identifying and inviting faculty members from each other's institutions to participate in conferences workshops and short courses. Terms and condition for such participation would be worked out by mutual agreement between invited faculty member(s) and institution extending such an invitation.

#### I. Exchange of Faculty and Students

AIIMS Rishikesh and UOP agree to explore ways of encouraging collaboration between faculties from two institutions. Specifically, two institutions would encourage members of their faculty to undertake short visits or take up fixed- term assignments as visiting faculty for-

- Guest lectures from AIIMS Rishikesh can be conducted on issues like-Lifestyle disorders, Medical ethics, scientific writing, Research methodology etc. UOP Haridwar can conduct guest lectures on Yoga in Alternative medicine, Yogic Science and Human Consciousness, Approach of Ayuvedic medicine in present scenario, Research methods in yoga and Ayurveda, Scientific approach or Ayurveda and yoga and its usefulness in modern era, Holistic health management, Importance of Ayurvedic and Yogic lifestyle in daily routein, Personality development and Self-management etc.
- Workshops from AIIMS Rishikesh can be conducted on 6 subjects like Evidence based medicine. Research Methodology, Scientific writing etc.UOP Haridwar can conduct workshops on Lifestyle management through vogic and ayurvedic techniques, Importance of Karma Yoga in daily routine, Role of advance Panchakarma techniques in chronic diseases, Meditative Practices and extrasensory perceptions, Role of yogic literature and practices in Cognitive functions, Stress Management in medical professionals through yoga etc.
- **Training** AIIMS Rishikesh will provide training in various aspects of health, hygiene and nutrition etc. UOP can arrange training programme in advance techniques in Yogic and Ayurvedic sciences.

Terms and conditions for each visit or an assignment, including those concerning stipend and travel, would be worked out between partner institutions.

#### C. Development of Herbal Garden:

UOP can provide the facilities and unique ideas for the development and expansion of Herbal Garden of AIIMS Rishikesh.

#### D. Exchange of science and technical material and data

- I. AIIMS Rishikesh and UOP will examine ways of exchanging information on research and education programs and teaching /learning material and other literature relevant to their education and research programmes.
- II. Both Institutions agree to explore ways to share teaching/learning material and other relevant literature, subject to each institutions policy on intellectual property and publication.

#### E. Intellectual property

AIIMS Rishikesh and UOP agree to respect each other's rights to Intellectual Property(IP). All background IP used in connection with this MoU shall remain property of party that introduces it. No license is granted to any party to use another party's background IP unless specifically agreed to in writing. Further, intellectual property rights that arise as a result of any collaborative research or joint activity under this MoU would be subject to separate written agreement/s on ownership and management of such intellectual property and each party agrees to respect ownership of IP of other parties in all dealings, consistent with officially laid down Intellectual Property Right (IPR) policies of partner institutions.

No party to this memorandum shall use name, logo or any other designation of any of other parties without prior written consent.

#### F. Co-ordination

Following arrangement is suggested for co-ordination of collaboration:

Each of institution AIIMS Rishikesh and UOP shall appoint one or two members of its teaching/research faculty to coordinate programme on its behalf. A coordination committee, consisting of (a) Director AIIMS Rishikesh or his nominee. (b) Vice chancellor, UOP or his nominee, (c) Programme Coordinator from AIIMS Rishikesh and (d) Programme Coordinator from UOP will periodically review and identify ways to strengthen cooperation between two institutions.

#### G. Tenure and Termination

This MoU will take effect from date it is signed by representatives of two institutions. It will remain valid for a period of five years. This MoU will be reviewed after three years; terms of this MoU may be amended by mutual

written agreement prior to date of review. Any extension to this MoU will be formally agreed in writing by Parties.

Either Institution may terminate MoU by giving written notice to other Institution six months in advance.
