

Minutes of the Board of Studies meeting of the Department of Tourism Management held on 05/06/2023 at University of Patanjali, Haridwar

A meeting of BOS of Department of Tourism Management was held on 05/06/2023 to design & implement the M.A. Yoga & Cultural Tourism Course.

The BOS meeting was begun at around 2.30 pm by conveying regards to the virtual presence of Param Pujya Swami Ji Maharaj and Pujya Acharya Ji Maharaj. Meeting was chaired by Dr. Om Narayan Tiwari Ji, Dean, Department of Yoga Science, University of Patanjali, Haridwar and conveyed by Dr. Aditya Bhargava, Incharge, Department of Tourism Management, University of Patanjali, Haridwar.

External Members that were present in meeting: Dr. V.K. Singh, Dean, FMS, Gurukul Kangri, University, Haridwar, Dr. Saras Verma, Assistant Professor, Department of Hospitality & Tourism, Quantum University, Roorkee and Dr. Arunesh Parashar, HOD, Dept. of Tourism Management DSVV Haridwar. Internal Members were Dr. Om Narayan Tiwari, Dr. Aditya Bhargava, and Ms. Bhavprita, Department of English, UOP.

Due to some reasons, Dr. Mahavir Agarwal Ji, Pro-Vice Chancellor, Dr. Pravin Punia, Registrar, Dr. V.K. Katiyar, Dean, Academics & Research, Dr. Sadhvi Dev Priya Ji, Dean Humanities & Ancient Studies, Dr. Nidhish Yadav, Dr. Vaishali Gaur, Dr. Anju Tyagi were not able to join the meeting. Ms. Bhavprita Ji from English department, joined the meeting in place of Dr. Anju Tyagi.

In the above title, following minutes were placed on record:

1. A copy of course structure was circulated among the present members to intake the valuable and necessary suggestions to formulate the course as per the guidelines of UGC in terms of CBCS.
2. By referring the course structure and syllabus, external experts and internal members appreciated the concept of combining Yoga & Tourism in terms of Cultural Tourism.
3. Title of Paper MYC-AEC-105 "Advance English Communication-I" was suggested to be replace with "English Communication" and similarly Paper MYC-AEC-309 title "Advance English Communication-II" suggested to be replace with "Advance English Communication"

4. It was also suggested that Tour Practical in each semester shall be of at least 2-3 days to any of cultural destination in India, that must include questionnaire, personal interview of tourists, stake-holders and localities, and survey, taken by the students.
5. It was also recommended, in papers MYC-DSE-404, MYC-DSE-405, MYC-DSE-405 titled "Dissertation work", "Field Work", "Corporate Training" that it should contain only two titles titled as "Dissertation work" and "Corporate Training".
6. It was suggested to include the case study of Airbnb in paper MYC-CT-203, "Travel Agency & Tour Operations Business".
7. All the presented members, subject experts appreciated the designed structure of the course that include major core papers of Yoga and Tourism, Cultural Tourism, Business Management and subject of computers as SEC, English Communication, and practical in Yoga and Tourism.

Amendment in Syllabus as per the recommendations of BOS Members present in the BOS Meeting of Department of Tourism Management held on 05/06/2023

1. As per the recommendation in Point no. 3 of the minutes, the title of Paper MYC-AEC-105 "Advance English Communication-I" has been replaced with "English Communication" and similarly Paper MYC-AEC-309 title "Advance English Communication-II" been replaced with "Advance English Communication". Same can be referred at page nos. 3, 4, 14 & 46.
2. As per the recommendation in Point no. 4 of minutes, that Tour Practical in each semester shall be of at least 2-3 days, the same changes have been done in the "Tourism Practicum" of each semester. Earlier it was limited to "One-day educational visit", now the "one-day" word has been removed, and Questionnaire, personal Interview, has been added in the course detail. The same can be referred at Page nos. 17, 29, 49 & 65.
3. Referring the recommendation in Point no. 5 of minutes, the change in the title of papers MYC-DSE-404, MYC-DSE-405, MYC-DSE-406 titled "Dissertation work", "Field Work", "Corporate Training" has been merged now it contains only two titles as "Dissertation work" and "Corporate Training" and same can be referred at page nos. 5 & 57.
4. As suggested in the point no. 6 of minutes, the case study of "Airbnb" has been included in paper MYC-CT-203, "Travel Agency & Tour Operations Business" and same can be refer at page no. 23.
