- Implementation

The Parties agree to the following terms and conditions for the implementation of this MoU:

- Exchange of Information

The Parties will exchange information related to their academic programs, research, and culture.

- Joint Meetings

The Parties will organize joint meetings to plan and implement collaborative activities.

- Communication



The Parties will establish a communication mechanism to facilitate the exchange of information, joint planning, and implementation of collaborative activities.

- Funding

The Parties will provide financial support for collaborative activities through joint funding proposals and other funding mechanisms.

- Intellectual Property Rights

The Parties will comply with the laws and regulations of their respective countries on intellectual property rights and will ensure that any intellectual property generated from collaborative activities is protected.

-Duration and Termination

It's a mutually agreed termination, if any dispute arises between the parties
